## **Presentation of the Kingdom of Saints Peter and Paul**

### **Birth of the Kingdom.**

Brief notes on recent history.

In 2009 Dr. Marcello Gentile established the Sovereign Military Hospital Order of SS. Apostoli Pietro e Paolo, recognized as "Subject of International Law in all the same way as a foreign State" with first degree sentence no. 01/2010 of 10 February 2010 issued by the International Civil Court - Permanent Body of the European Court of Arbitration of Ragusa. This ruling, having the effect of a ruling pronounced by the Judicial Authority of the Italian Republic, enforced by the Court of the Italian Republic with a Decree of enforceability of Judgment no. 166/2010 - REP. nr. 410 of the President of the Ordinary Court of Ragusa of 9 March 2010, became irrevocable on 1 December 2010.

It has definitively established that:

"The Sovereign Military Hospital Order of SS. Apostoli Pietro e Paolo is legitimately subject of International Law in all the same way as a foreign State; as such it has the right to rights and obligations deriving from the International Legal Order; Jurisdictional and Tax Immunities compete with it with the legal treatment of States; consequently, the measures pronounced by your courts have the nature of jurisdictional measures of a foreign state. The Sovereign Military Hospital Order of SS. Apostoli Pietro e Paolo is legitimately neutral in perpetual way "(Article 2 of the Constitution of the Sovereign Military Hospital Order of the Holy Apostles Peter and Paul notified for public proclamations in the Official Gazette of the Sicily Region of 6.11.2009, No. 45, part II, page 21, advert n ° 75).

"The Order is independent and sovereign and as such the Italian Law of 3 March 1951, No. 178, has no effect on it; consequently, the Sovereign Military Hospital Order of SS. Apostoli Pietro e Paolo is a non-national Order of Merit and, therefore, is not among the criminal cases envisaged and punished by Italian Law No. 178/1951".

Furthermore, the Order, as established by its Constitution, "can carry out all the financial, movable and real estate transactions necessary and useful for the achievement of its objectives [...] has the right to establish Representative and

Correspondence Offices in any part of the world [...] has the right to Active and Passive Legation ”.

The recognition of the Order as an entity with international validity, because it has the requisites required by International Law, coincided with the recognition of Dr. Marcello Gentile, already by family and legal law Don Marcello Gentile, as Sovereign Grand Master of the Order, in as much as its founder. Don Marcello Gentile obtained the historical recognition of the full and exclusive sovereignty of a "terra nullius" (no man's land), located in the Antarctic Continent and included in the sector between the South Pole and the 60 ° South latitude and contained between longitude 141 West and longitude 150 ° West.

This recognition is definitively sanctioned by sentence no. 3/2012 pronounced on 3 July 2012 by the International Civil Court - Permanent Body of the European Court of Arbitration of Ragusa, having the effect of a sentence pronounced by the Judicial Authority of the Italian Republic.

This sentence became irrevocable on February 18, 2013, with the right to be mentioned in the official geographical maps.

The Sovereign Military Hospital Order of SS. Apostles Peter and Paul, having thus acquired the Territorial Sovereignty, is transformed with the Constitutional Law / Sovereign Act of Promulgation of the Constitutional Law nr. 1 / R / 2011 of 22 December 2011 in the Kingdom of Saints Peter and Paul, an independent and sovereign state in all respects of law, endowed with a people, a government and a territory.

What was declared was sanctioned in the same sentence no. 3/2012 pronounced on 3 July 2012 by the International Civil Court - Permanent Body of the European Court of Arbitration of Ragusa, becomes irrevocable on 18 February 2013.

The first instance sentence, registered in no. 2/2014 of the Special Register of the European Court of Arbitration of Ragusa, pronounced in Lecce, on April 18, 2014, by the International Arbitration Court - Permanent Body of the European Court of Arbitration of Ragusa, having the effects of a sentence pronounced by the Authority Judicial of the Italian Republic, pursuant to art. 824 bis of the Code of Civil Procedure, irrevocable on 3 December 2014, has ascertained and declared, among other things, that the Kingdom of Saints Peter and Paul has sovereign jurisdiction over Northwestern Antarctic territory, better indicated within the 60 ° boundaries 0'SUD - 75 ° 0'SUD and 15 ° 0'WEST - 20 ° 0'WEST.

The Constitution of the Kingdom, promulgated with a specific Constitutional Law, establishes that "Don Marcello Gentile, Prince of San Pietro, exercises the attributions of King and Sovereign of the Kingdom of Saints Peter and Paul and assumes the title, with the treatment of His Majesty, with the dynastic name of Don Marcello Maria I ". This appointment, and the whole Constitution of the Kingdom of Saints Peter and Paul in its integrity, is fully recognized by sentence no. 3/2012 pronounced on 3 July 2012

by the International Civil Court - Permanent Body of the European Court of Arbitration of Ragusa which became irrevocable on 18 February 2013.

The ruling states that

"to His Majesty the King of the Kingdom of Saints Peter and Paul, being Sovereign on the Throne with a Population, a Government and a Territory on which he exercises Sovereignty, the Sovereign Prerogatives connected to the Jus Imperii legitimately belong, that is the Right of Command, to the Jus Gladii that is the right to impose obedience with the command, to the Jus Majestatis that is the right to be honored and respected, to the Jus Honorum that is the right to reward merit and virtue " .
